## LACLJ Helps Parent Avoid Detention

LACLJ provides trainings to raise awareness about issues impacting the community, including domestic violence, human trafficking and Know Your Rights. At a recent training, LACLJ shared Know Your Rights tips to parents of middle school children. Some of these tips include your **right to speak with a lawyer** before signing or saying anything, your right to remain silent and not open your door if ICE comes to your home, and to plan ahead and **make a family preparedness plan** with your loved ones.

Lydia\* was one of those parents who attended the training. A few days later, ICE came knocking on her door. They said they had an arrest warrant for her. **Lydia stayed calm and remembered the tips we shared. She asked to see the warrant through the window and saw that it was not signed by a judge.** Lydia refused to open the door and the ICE agents left her property.

For many families, ICE showing up is a terribly scary situation. Knowing their rights and options can help survivors decide how to respond in a way that it is as safe for them as possible. For more tips, [visit the ILRC Know Your Rights Resource Page](#).

In addition, Alex has been working on an **educational brochure** to help inform survivors on what public benefits they're eligible for based on their immigration relief and how to apply for them.

As a rising 3L from Indiana University who also works at an immigration law firm in Indiana, Alex saw that many immigrant survivors were not aware of the public benefits that they could receive and/or were afraid of accessing them. Through this project, she hopes to raise awareness in the community and provide a tool for LACLJ and others to educate immigrant survivors.
