ADVOCATING FOR A TEEN'S RIGHTS

Cassandra* is 16 years old. She had been dating her 19 year old boyfriend for nearly a year, but wanted to break up with him. He was controlling and violent. **After she ended the relationship, he began harassing her.** He messaged Cassandra non-stop and even parked his car outside of her home.

The District Attorney filed charges against Cassandra's ex, but **she was nervous about testifying in a criminal case.** So, she came to LACLJ for help.

We helped Cassandra navigate the criminal justice system, asserted her Marsy's rights as a victim, and advocated with the D.A. to address her concerns.

With our support, Cassandra felt empowered and chose not to testify. She was relieved that she wouldn't have to face her abuser in court. He was convicted in his criminal case and now Cassandra can focus on healing from the trauma she experienced and finishing high school.
