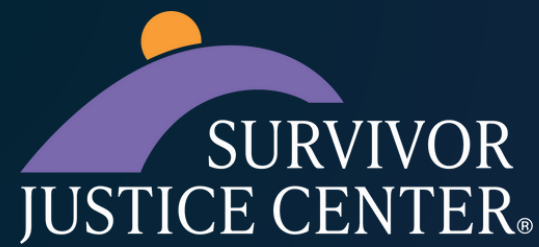

Impact

Family Law

To protect the safety of survivors and their children, attorneys help domestic violence survivors obtain restraining and custody orders.

Criminal Justice Advocacy

Attorneys help sexual assault survivors navigate the criminal justice system and understand their rights so they can feel empowered in court.

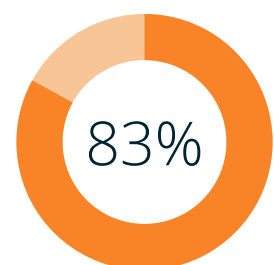
Immigration Relief

Attorneys help families pursue humanitarian-based immigration visas so they can start their path to legal status and financial stability.

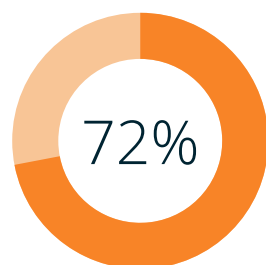
Supportive Services

Social workers assist survivors with safety planning and linkages to other community resources that support their well-being.

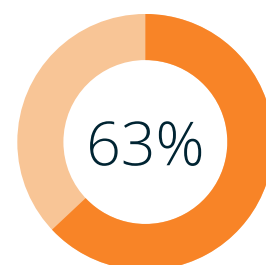

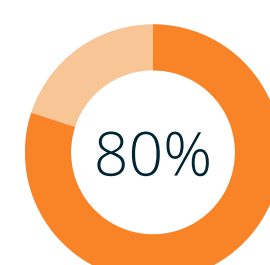

ABOUT THE EMPOWER RUN

The Survivor Justice Center's 5th annual Empower Run will take place on March 15, 2025 at Dodger Stadium.

In partnership with the LA 5K, our community of supporters have the opportunity to run and walk together in support of survivors of domestic violence, sexual assault and human trafficking.

The LA5K is open to participants of all ages and abilities, including runners, walkers and strollers and is attended by over 8,000 people. Starting and finishing in front of Dodger Stadium, participants experience a beautiful course through Elysian Park. Each participant will receive an LA Big 5K shirt and finisher medal, as well as a Survivor Justice Center Empower Run race shirt.

Funds raised by the 2025 Empower Run will provide access to free representation and legal services to low-income survivors and help them secure safety, justice and stability.
